### **Additional Information on Benefits:**

#### **Family Level Memberships**

All Community Partner membership levels include a set number of one-year Family\* level memberships that can be gifted to employees, partners or clients.

#### **Reusable General Admission Cards**

General admissions cards are valid for visiting 50+ Mass Audubon sanctuaries across the state, during normal hours of operation, with the exception of occasional fundraising days. Each card is reusable and allows for free admission for one family\*\* per visit. General admission cards must be presented at the time of visit.

#### **General Admission Passes**

All Community Partner membership levels include a set number of one-time use admission passes. These can be used by employees, customers or clients for general admission to Mass Audubon wildlife sanctuaries across the state, during normal hours of operation, with the exception of occasional fundraising days. They can also be donated to local area non-profits, schools, or social service agencies. Each pass allows for free admission for one family\*\* per visit. General Admission Passes must be presented and will be collected at the time of visit.

**Executive Invitations to Outings**

Community Partners at the Upland and Summit level receive an invitation for two to join six expert-led nature walks/programs annually.

**Invitation to Annual Meeting Reception**

Community Partners at the Upland and Summit levels receive an invitation for two to attend Mass Audubon's Annual Meeting Reception.

**Savings on Employee Purchased Memberships**

Family and Individual level memberships are available for employee purchase for only \$32, which is half-off the regular rate (this discounted rate is valid for new members only, and memberships must be purchased at your Community Partner sanctuary).

**Special Event/Program Passes**

All Community Partner membership levels include a set number of special event/program passes. Each pass offers free admission to a special event or program at your Community Partner sanctuary.

**Complimentary Program by Mass Audubon Naturalist**

Community Partners at the Upland and Summit levels can arrange for a special nature program, walk or other activity for employees, at your Community Partner sanctuary or at your place of business.

*\* Mass Audubon Family level membership is valid for up to two named adults in the same household, and their children or grandchildren under the age of 18. Members enjoy free admission to Mass Audubon's statewide network of wildlife sanctuaries, savings on programs and classes, discounts and special sales at our gift shops, and more.*
