## OUR CAMP DIRECTOR

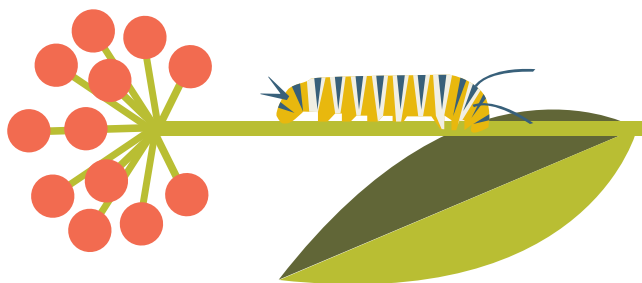

### KNEE-HIGH NATURALISTS

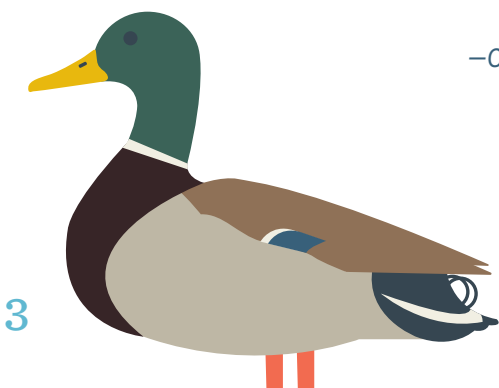
Ages 3–4

Counselor-to-Camper Ratio: 1 to 5

Discover the wonders of nature this summer! Explore the trails at Pleasant Valley, play games, sing songs, make crafts, and listen to stories. Counselors are specially selected based on demonstrated ability to lead younger children in the outdoors. Campers must be at least age 3 by June 1.

# FULL-DAY NATURE CAMP

Monday–Friday, 9:00 am–3:00 pm  
8 week-long sessions, June 27–August 19

## DISCOVERERS

Ages 5–6

*Counselor-to-Camper Ratio: 1 to 5*

Nature truly is a magical place where wonder and adventure are waiting to be discovered behind each and every tree. Explore Pike’s Pond, Yokun Brook, and the fields and forests at Pleasant Valley; play games; and sing camp songs. Look for pond creatures and build secret “gnome home” villages in the woods. Gain a greater connection to nature and curiosity about the outdoors, and learn how you can be a steward of the natural world.

## EXPLORERS

Ages 7–9

*Counselor-to-Camper Ratio: 1 to 7*

Get curious this summer as you explore the far reaches of Pleasant Valley in search of the hidden wonders of the natural world. Be ready for days packed with new sights, sounds, smells, and games as you get to know the sanctuary’s many habitats: Hemlock forests, vernal pools, and beaver ponds await! Build survival shelters and learn to identify plants and animals. On Wednesdays, hike to the top of Lenox Mountain and on Thursdays, venture to the far reaches of Pleasant Valley’s trails where no other camp groups go.

## NATURALISTS

Ages 10–13

*Counselor-to-Camper Ratio: 1 to 5*

Discover the incredible complexity of the natural world. Explore the sanctuary off the beaten path, play games, and use real scientific techniques to investigate the outdoors. Learn how to track wildlife and recognize birds by their songs. Hike the legendary Trail of the Ledges and dive deep into the science of Pleasant Valley!

# TEEN PROGRAMS

Ages 13–17

## NEW! ENVIRONMENTAL LEADERSHIP FOR TEENS

June 27–July 1, August 1–5

Jump-start your climate activism skills in this environmental leadership intensive. Develop leadership skills and action steps to combat climate change in your community. Alongside your peers, you’ll learn how to identify areas that are especially vulnerable to the effects of climate change, and locate resources you can utilize to address those vulnerabilities. You’ll participate in service projects around the sanctuary, and see what climate action looks like at Mass Audubon.

At the end of your session, we’ll help you set goals to take on a climate action project of your own in your community. Connect with youth climate groups within Mass Audubon and across Massachusetts, so you can keep the momentum going!

## CANOE CAMP

August 8–12

*Includes trips to: Multiple sections of the Housatonic River, Buckley Dunton Lake, and Goose Pond*

The Berkshires are one of the more water-rich places in North America and contain wonderfully diverse rivers, lakes, and wetlands. Explore by boat some of the most biologically unique places in the county and learn real scientific techniques such as water chemistry tests and microscopy, used to study freshwater ecosystems. Be prepared for full days on the water and get ready to see a side of the Berkshires few people ever do! Canoe Camp staff are all trained in first-aid, CPR, and small watercraft safety.

Join us for the return of camp to Canoe Meadows  
Wildlife Sanctuary!

Set along the banks of the Housatonic River, Canoe Meadows is located less than a mile from downtown Pittsfield. The sanctuary is home to a wonderful diversity of habitats including extensive fields, forests, wetlands, and the restored Sackett Brook and its floodplain forest.

### PAINTED TURTLES

Ages 5–7

Counselor-to-Camper Ratio: 1 to 5

Learn about plants and animals, hike the property, use your senses to explore the environment, and play with new friends. Small group size ensures that each child is heard and has opportunities to contribute.

### BLUE HERONS

Ages 8–10

Counselor-to-Camper Ratio: 1 to 7

Work cooperatively to explore Canoe Meadow's various ecosystems, play interactive games, and dig deeper into native species' adaptations, behaviors, and food webs. Learn about our climate here in Massachusetts and how you can play a role in conserving the nature of our state.

### COUNSELORS-IN-TRAINING (CIT)

Ages 14–17

*\*This is a volunteer program and requires an application but does NOT include a cost*

Training Date: Friday, June 24

Do you love being outdoors and working with kids? Become a Counselor-In-Training (CIT) and share your love of nature with younger campers while acquiring valuable leadership skills. CITs are a vital part of our camp program, and many go on to become full camp counselors.

# REGISTRATION INFORMATION

To provide equal access to camp for everyone, we request that you register for no more than four sessions of camp per child.

## REGISTRATION CONFIRMATION

A confirmation letter/e-mail containing important documents and information will be sent once your camper's registration has been processed.

## DEPOSIT

A nonrefundable deposit of \$50/camper/session is required to register for camp. The deposit will be applied to your camp tuition and cannot be transferred to another camper, family, or camp location. If registering after May 2, payment in full is required (unless a payment plan has been established with the Camp Director).

## REFUND POLICY

A full refund, minus the nonrefundable deposit, is provided to camp families who cancel in writing on or before May 31. After May 31 no refund is available. Deposits are not transferable, and refunds are not given for participant dismissal, failure to attend, absence or sick days. If we must cancel a session, you will receive a full refund.

## MEMBERSHIP & DISCOUNTS

Mass Audubon members at the Family level or above receive a discounted rate. To qualify, your membership must be current through your camper's last session, and you must be the parent, grandparent, or legal guardian of the camper being enrolled. Membership can be purchased or renewed at the time of registration.

## SLIDING SCALE

Under the sliding scale model, every family will enroll for camp at a tuition rate based on their annual gross income. At registration, you will have the opportunity to select the pricing that best fits your family's gross income bracket. You will be asked to upload income verification documentation at a later time if you selected Tiers 1-4. Registrants at Tier 5 are not required to provide income verification. A deposit

is due at the time of registration; the final balance and all paperwork are due by May 2, 2022. If cost is still a barrier under the tiered structure, financial assistance (in the form of scholarships) is also available.

## IMPORTANT DEADLINES

**All camp forms, waivers, and the balance of your camp tuition are due by May 2.** If registering after May 2, payment in full is required and a specific camp form deadline will be set for you. A camper cannot attend camp and their spot is not guaranteed until all forms, waivers, and payments are completed (or a payment plan has been established).

## CAMPER REQUIREMENTS

Campers are expected to be able to follow all COVID-19 safety protocols, to be determined by the start of camp based on the latest guidelines from the Massachusetts Department of Public Health. All campers must follow stated behavior expectations and safety rules. To ensure a successful camp experience, please discuss any pertinent information regarding your child's needs with the Camp Director. We strive to make camp a great experience for all, and we can accommodate on a case-by-case basis. The Camp Director reserves the right to dismiss a camper when, in their judgment, the camper's behavior interferes with the rights of others or violates the camp's safety and behavior policies. In such cases, no refunds will be provided. If you have any questions regarding your child's ability to participate in our camp program, please contact the Camp Director.

## CAMP LICENSE

Our camp complies with the regulations of the Massachusetts Department of Public Health (105 CMR 430) and is licensed by the Tri-Town Board of Health.

## ACA ACCREDITATION

We are proud to be accredited by the American Camp Association. Developed exclusively for the camp industry, this nationally recognized program focuses on program quality, health and safety, management, and camp operations.

## FINANCIAL AID

We believe connection with the natural world should be available to all. If finances are getting in the way of a summer at Berkshire Nature Camp, financial assistance is available based on demonstrated financial need and available funds. Scholarships are limited to one session per child; however, all applications are considered and will be accepted on a rolling basis. Payment plan options are also available.



# REGISTRATION INFORMATION (continued)

## CAMP POLICY REQUESTS

You may request copies of our background check, healthcare, discipline, bullying, and grievance policies at any time.

## SESSION TRANSFERS

Sessions transfer requests will be honored if there is space available and if a request is made at least two weeks prior to your camper's session start date.

## BUDDY REQUESTS

One buddy request per camper will be honored when possible. Both campers must be the same age and both must request each other. All buddy requests must be made in writing at least one week prior to the first day of camp. Please indicate on your registration form if you would like your camper to be placed with a friend of the same age.

### Winter Adventure Vacation Week
